

## TERMS & CONDITIONS

By becoming a client of Guardian Soccer Academy, you agree to the following terms.

1. Refund Policy – No refunds are given for any reason or circumstance. Our program has limited availability and each spot is in demand. Waiting lists are utilized for our private 1on1 training and small group program. All sales are final.
2. Rainout/Weather Policy – If the fields are “too wet” or if there is severe weather during the time of our scheduled session, the session may be rescheduled upon Coach Tully’s decision. He will check to make sure conditions are safe before every session. If the field is playable and it is safe, we will resume the session. Parents do not determine if the session is cancelled.
4. Missed Session Policy – If a session is missed, the session is forfeit unless communicated with Coach Tully at least 24 hours before the session. If communication is received 24 hours prior to the session, Coach Tully will do his best to accommodate a makeup session.
5. Player Conduct Policy – All players are required to show up on time for each session with proper soccer attire. All home training assignments are expected to be complete.
6. Payment Policy – By committing to our 3, 6 or 12 month agreement, you agree with the signed contract that you will honor the entire commitment. You have the option of paying in full (discount), or paying monthly via electronic payment.
7. Early Contract Termination Policy – If you choose to cancel during the 3, 6 or 12 month contract, you can cancel anytime by notifying Coach Tully at [seanmtully17@gmail.com](mailto:seanmtully17@gmail.com). By canceling the contract, you understand our early termination policy:

### **Early Termination Policy:**

You can opt out of and cancel your contract anytime by paying Guardian Soccer Academy a 50% of total agreement early termination fee. Paying the fee will cancel any upcoming payment and once the fee is paid, all sessions will come to a close.

8. Training Contract – By agreeing to our 3 month program, all sessions must be completed within 3 months from the start date. By agreeing to our 6 month program, all sessions must be completed within 6 months from the start date. By agreeing to our 12 month program, all sessions must be completed within 12 months from the start date. If the sessions are not completed in a timely manner, you will forfeit the sessions.
9. Recurring Monthly Fees – By committing to our 3, 6 or 12 month program, you agree to paying the monthly fees in full up front, or on or before the agreed upon day each month.

10. End of Contract & Renewal Policy – If you would like to STOP training after our contract is complete, simply email Coach Tully at seanmtully17@gmail.com.com 30 days prior to the final session that you will be discontinuing the program. If you do not communicate with Coach Tully 30 days prior to the final session, you agree to continue in the program beyond the agreement (meaning we hold your spot in the program) and you will continue to train in the program.
